### **STAFFING**

# **Designated Early Childhood Educators**

For the 2014/2015 school year the total FTE for our DECE positions is ninety-two (92).

# **Educational Assistants**

Currently for the 2014/2015 school year the total FTE is three hundred and one (331.00) Educational Assistant positions-this equates to about 350 members. We will monitor how many temporary positions are being allocated in schools which are not for any statutory, personal, education or medical leave as the board has put into place a number of temporary positions until November 28<sup>th</sup>. The board reviews the positions to determine if these positions need to be extended. We are closely monitoring this as the board does not have to post these positions therefore the principal gets to choose who fills the position.

# **PAY EQUITY**

As you are aware the SMCDSB had decided that they believed that the process we used for Pay Equity was flawed. Because of this we put in a complaint to the Pay Equity Commission. Our OSSTF Lawyers, OSSTF representative, EA/DECE President Patty Coates and O/C President Suzanne Conley-Cholak met with the Board and a Pay Equity Review Officer on October 28, 2014 in Barrie. We are following the process as set out by the Pay Equity Act and the Review Officer.

### **STRIKE VOTES**

We are quite please with our results of the strike vote. A reminder that the results of these votes are confidential until told otherwise.

#### **JOB CLASS MEETINGS**

We will be holding Job Class Meetings in November – Wednesday, October 5<sup>th</sup> for DECE members including supply and on Monday, November 10<sup>th</sup> for EA members including supply. Many topics will be discussed which are pertinent to the specific job class including working conditions, programs and pressing issues/concerns. At this time we have fifty-six (56) DECE's and eighty-one (81) EA's registered.

# **SCHOOL REP TRAINING**

We are organizing full-day training for our School Representatives half on Monday, November 10, 2014 and the other half on Monday, November 117, 2014. We have 100% registration for Monday, November 10<sup>th</sup> and working on the same for November 17<sup>th</sup>.

- Supervision As with each year there are some issues with members being asked to do more than 16 minutes of general supervision per day or at one time. In addition; some members have been asked to do general supervision while supervising students with special needs.

Nowhere in the document does it state that Educational Assistants and Designated Early Childhood Educators report to or take direction/orders from a SERT or do they have to tell a SERT that they are going to be away and why. Please familiarize yourself with these two sections in the Kaleidoscope binder. Contact your union office if you find the roles are not being followed at your school.
